Donald Trump is publicly considering firing Special Counsel Robert Mueller, the person leading the Department of Justice investigation of possible criminal actions by Donald Trump and members of his presidential campaign, as well as the efforts to conceal those activities.

It's also possible that, rather than firing Mueller, Trump will obstruct

Mueller's investigation by issuing blanket pardons of key figures being investigated, firing Deputy Attorney General Rod Rosenstein (the person overseeing Mueller), or taking other actions to prevent the investigation from being conducted freely.

Any one of these actions would create a constitutional crisis for our country. It would demand an immediate and unequivocal response to show that we will not tolerate abuse of power from Donald Trump. Pennsylvania's [18th Congressional district](#) is up for grabs, thanks to the ethics-challenged incumbent Tim Murphy, who was forced to resign when his mistress revealed that he had asked her to have an abortion while championing anti-choice legislation! Democrats have just pulled off their second upset of 2018. A Republican legislative seat in Missouri flipped from red to blue on Tuesday night as Democrat Mike Revis won House District 97. This district went heavily for Trump, giving him a 61-33 margin in 2016.

This seat had been in GOP hands for at least eight years, but on Tuesday, Revis captured it with a 3 point victory—a massive [31-point swing](#) from the 2016 presidential results. This makes it the 35th seat that has gone red to blue since DJT became president.
