ELECTIONS- Ballot Referenda

Today we offer background on one of the referenda you'll find on your Howard County ballot. We'll cover the rest as we approach the election.

Election Day Registration – 2018 General Election Ballot Question

Question #2 on the 2018 Maryland General Election Ballot proposes a change to the Maryland State Constitution to allow Election Day Registration. The constitutional amendment authorizes the Maryland General Assembly to enact legislation to allow a qualified individual to register and vote at a precinct polling place on Election Day. The current law requires voter registration to close before Election Day.

A report from the Department of Legislative Services Office of Policy Analysis Annapolis, Maryland, dated November 2017 states: “There are currently 15 states and the District of Columbia that allow same-day registration. To ensure the security of the process, all jurisdictions require same-day registrants to show some form of identification, and many jurisdictions also require at least some same-day registrants to cast a provisional ballot that is only counted after the individual’s eligibility is verified. Maryland is one of only two states that limit same-day registration to the early voting period. Most jurisdictions allow individuals to register at all precinct polling places on Election Day, while the rest allow same-day registration only at one or more central locations within a local jurisdiction.”

Voting “For” this ballot question will encourage and enable more Maryland residents who are eligible to vote to cast their vote on

Election Day. Voting “Against” this ballot question will maintain the current requirement to register prior to Election Day. We encourage our members to vote For.
