# Indivisible **HoCoMD**

**Voter turnout** for all 8 days of early voting was 21.93% of eligible voters in Howard County. Over 5% better than Maryland as a whole.

**Nationwide** young people are already turning out in large numbers:

**18-29 year old turnout in early voting**, compared to this point in 2014, is:

- 5x higher in Texas
- 5x higher in Nevada
- 4x higher in Georgia
- 3x higher in Arizona

And young people are organizing a school walkout on Nov 6th at 10:00 am to encourage themselves and others to vote.

**Something to anticipate,  
from John Leonhardt at NYT:**

**The right to vote.** I recently asked Leah Greenberg and Ezra Levin — co-

founders of the progressive grass-roots group **Indivisible** — what they hoped to see from Democratic presidential candidates once the midterms were over. Their answer: “Candidates bidding to out-democracy each other.” By that, they meant proposals that would make it easier for Americans to get involved in politics — and for politics to reflect the popular will. Greenberg and Levin didn’t go into detail, because they said they wanted to listen to the ideas that come forward. But you can imagine the kind of ideas they’re talking about: Voting-rights protection. Gerrymandering reform. Campaign-finance rules.

## PRESS RELEASE

### **Attorney General Frosh’s Statement on Court Denying President Trump’s Attempt to Delay Discovery in Emoluments Lawsuit**

**BALTIMORE, MD (November 2, 2018)** – Maryland Attorney General Brian E. Frosh today released the following statement:

*“The President’s latest attempt to block our emoluments lawsuit has failed once again. We are gratified that the court has denied the President’s efforts to keep our case from proceeding to discovery. Today’s decision affirms once again that Maryland and the District of Columbia have standing to sue, with the court emphasizing that the President’s proposed definition of the term emolument is ‘exceedingly strained’ and would prohibit only ‘what is tantamount to a bribe.’ We agree with the court that the President’s motion was nothing more than an attempt to delay the ultimate resolution of our lawsuit, a tactic that the court said ‘as a matter of justice, cannot be countenanced.’”*
